### Another Tax on Services Effort Expected in California

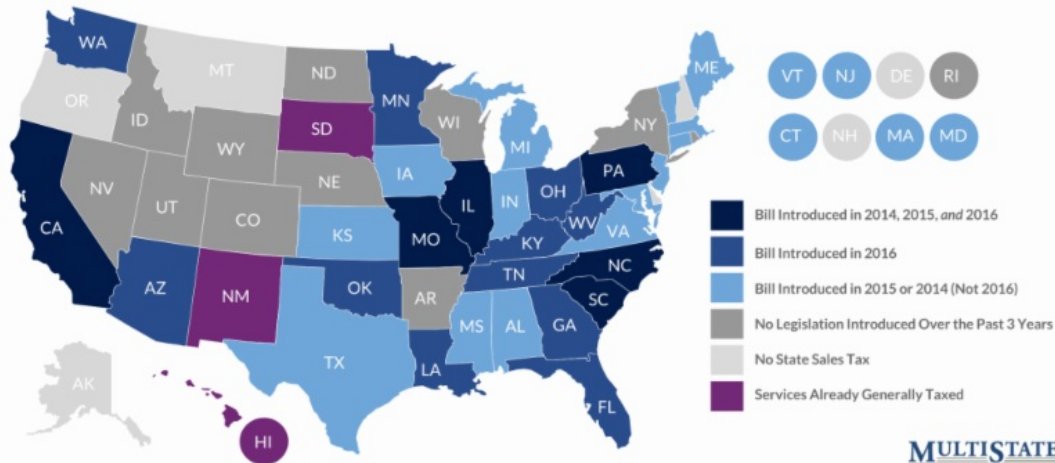

Tax on services (TOS) proposals have become increasingly prevalent in state legislatures across the country over the last few years, and 2017 will be no exception. As of January 2017, TOS proposals could emerge and be seriously debated in 16 states during upcoming state sessions. These predictions are driven by four factors:

1. Deteriorating budget pictures in many states and a desire for new revenue sources;
2. Changing politics post-election;
3. A gradual shift in policy perceptions, with the desire to move away from income taxation and toward consumption taxation; and
4. States' past interest in TOS proposals and top lawmakers' recent statements indicating that TOS is on the table.

In California, former Speaker and Senator Robert Hertzberg (D) has been advocating for a broader sales tax for several years, and his voice carries considerable weight. A TOS bill has been introduced every year for the past three years.

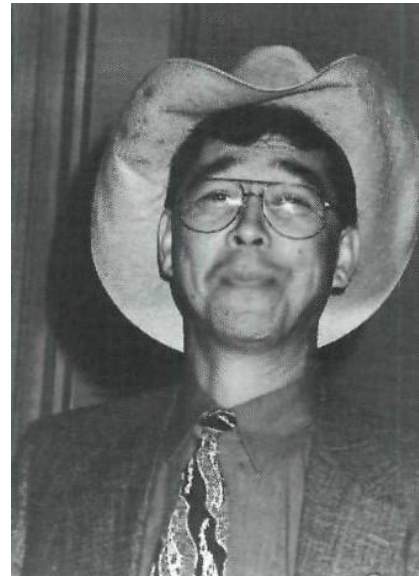
## In Memoriam: CLSA Past President Billy Martin
