CSRS EPOCH 2017.50 (NAD83) Now Available

The California Spatial Reference Center (CSRC) is pleased to announce that the CSRS Epoch 2017.50 (NAD83) is now available. This project was completed through a contract with the California Department of Transportation (Caltrans). Through this update, the CSRC will continue to provide users in the State with a high-accuracy reference network. The results of the CSRS Epoch 2017.50 (NAD83) update, along with the final project report documenting the project and its conclusions are available on the CSRC website <http://csrc.ucsd.edu>. The epoch update materials currently available are a data table showing the coordinate values with velocities and accuracies of each CGNSS station, a comprehensive Project Report, and a table assessing station quality. More information, such as kml files, will be available soon. In addition, the CSRC website is evolving and being updated to provide a modernized map interface for accessing coordinates and data files.

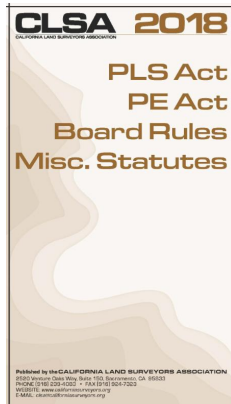
