# NGS NEWS - DELAY IN PUBLISHING FINAL DETERMINATION FOR RETIRING U.S. SURVEY FOOT

To allow additional time to analyze public comments, the planned date for issuing the final determination on deprecating the U.S. Survey Foot has been extended by 90 days, from June 30, 2020, to September 28, 2020. The original October 17, 2019, Federal Register Notice on this action includes a link to the public comments received.

The National Institute of Standards and Technology's (NIST) Office of Weights and Measures and NOAA's National Geodetic Survey (NGS) have co-issued a Federal Register Notice (FRN) announcing this extension.
