Continuing education has been a common topic in my discussions with surveyors throughout the State, as well as often discussed with our peers in adjoining States. Not the least of which is an increase in disciplinary actions by those State's Licensing Boards. I'd like to encourage all of you to continue to promote CE requirements and do what you can to make yourself better. Those who have the power to enact CE requirements won't be inclined to do so if the industry (you and me) are not actively continually educating ourselves first.

Do what you can to keep learning. Re-read your old textbooks. Take advantage of the many online seminars found on the CLSA, WFPS, and NSPS websites. Attend a CLSA Chapter meeting. Attend a Conference. Find a mentor. Be a mentor.

WHERE OUTSIDE CALIFORNIA IS THIS?

Where IN CA is This?




The October "Where Outside CA?" was identified by Buck Rogers, PLS. He said "I used the picture identification tool in Google Chrome. This is perhaps cheating, but maybe not. Tri-State Marker - Texas, New Mexico and Oklahoma|

Set on top of a pedestal. This marking is on the 103 Meridian." But Tim Reilly, PLS, said "That image is of the Initial Point for the Cimarron Principal Meridian. I visited that IP in the middle of the night many years ago. If I'm not mistaken, the monuments originally marked the TX-OK state boundaries, but those boundaries were later changed. I'm pretty sure the stamping of the monuments had old marks reflecting the former state boundary. I'll have to dig up my old photos." Which he did – Tim's midnight photo is a close-up, and gives us a Two-fer... The Cimarron IP is often confused with the "Texhomex" monument. If Tim had only gone a little farther south, he would have seen both. The photographer, Bob Robinson, LSIT, retired from Caltrans, D-11 said he saw a sign along the highway that said "Tri-State Corner Monument next exit" so off he went. The monument was found with little fanfare surrounding it, about a mile and a half mile south of US Route 412. To add to the confusion, there is another monument in the vicinity to the west as shown in the SE quadrant of this map. Note the highway clipping the NW corner of the map.

NCEES announced at their Fall POLC Meeting the annual exam counts by Fiscal Year (FY) (October 1 to September 30). The FY 2023-2024 number for Fundamentals of Surveying (FS) exams delivered was 2244, up from the 2123 delivered in FY 22-23 and the budgeted number of 2000.
