Greetings, Fellow Surveyors,

After following up with Central Office, I found out that our corporate membership is over the 1,000 mark and we have nearly 300 corporate members who have not renewed their membership yet.

Kimi Shigetani, our Executive Director, sent out reminders for those who have not renewed yet. Membership is the association's lifeblood and larger membership numbers strengthen our fiscal standing and increases our advocacy power. Membership rosters are due on July 31, 2025, and I feel we are off to a good start.

Our joint conference with NALS is approaching fast, starting on Saturday, March 29, 2025, with the Workshop seminars and the official Opening on Sunday, March 30, 2025. WHERE IN CALIFORNIA IS THIS?



The February “Where in CA” was south of Indio, CA, on the westerly side of State Highway 86. The following people correctly identified the location: Philip Melcher, John Henderson, Andrew LaBine, and, with a detailed description, I will rely on Desert Dweller, Historian, and Land Surveyor Tim Reilly:

“This one was easy. That's Travertine Point, aka Travertine Rock, near the Imperial/Riverside County line. There are many shrines that have been placed amongst the rocks and graffiti. I've driven by it many times and twice have used the remains of the triangulation station on top of that rocky hill as horizontal control in my surveys. The NGS datasheet for station “Travertine” says the station was marked was a typical Caltrans disc, originally stamped 1971. However, a 1974 Caltrans control survey (R/W 231) states that the disc was set by U.S. Army Engineers. A souvenir hunter must have thought the brass disc was valuable and removed it from its setting. All that remains is a drill hole and partial brass stem.

Travertine Point has a historical role in our local surveying. When railroad surveys were ordered by the Secretary of War, Jefferson Davis, circa 1853, it became the role of Topographical Engineer Lieutenant R.S. Williamson to find a suitable route for the railroad to connect the 35th and 32nd parallels. It was when the railroad surveyors rounded Travertine Point that they realized their route would connect Tehachapi & Los Angeles on the 35th parallel to Fort Yuma on the 32nd parallel. William P. Blake, who accompanied the survey as geologist and mineralogist, described the occasion in his journal:

“...From these rocks I obtained a fine view of the Great Desert, stretching off towards the southeast in a wide, apparently limitless, plain, its only boundary the unbroken outline upon the distant horizon. Not a green spot in all this wide expanse was to be seen ; the bald mountains near me were not only free from trees, but there was not even earth to cover the

rocks. The mountains opposite extended off towards the east until they were lost to sight in a series of low summits of a deep-blue color. The intensity and richness of the colors of the distant hills was very striking and beautiful. Blue, purple, and red were the prevailing tints, and their clearness and depth were remarkable. They were delicately blended one with the other, and produced a most beautiful effect, which it is impossible to describe..."

The photo in this month's newsletter was taken about 100 feet below sea level. The 1853 railroad survey was first to mention in their report that the area was formerly under a massive body of water. A sketch of the ancient water line along the rocky mountains accompanied Blake's report. See attached. The level of today's Salton Sea is several hundred feet below the ancient water line.

The Second Standard Parallel South, S.B.M., passes very near the photo location. The original 1855 GLO surveyor set the standard quarter-section corner on the North line of Section 5 "about 20 chains North of a "round rocky hill". (Oddly, the standard corners were originally set to control corners on the North boundary of the T. 9 S.) A later 1922 GLO surveyor called the rocky hill "Tuva Point". His notes in T. 8 S., R. 9 E., S.B.M. returned a bearing from at least one corner monument to a flag on top of the hill."




