#### A MESSAGE FROM THE PRESIDENT

Questions? Comments? Concerns? Contact me: Ca.PLS8200@gmail.com or 559-451-7112. The word "unprecedented" has been getting a lot of use in recent years, and rightly so. The natural disasters we've been experiencing within our State have been happening with an increasing ferocity and frequency. Each one is unprecedented... until the next one, which is seemingly more unprecedented.

The earthquakes, floods, and wildfires are becoming so common and widespread that most Californians know someone personally affected by them, if not themselves. As this Association is statewide, we can all point to someone we know through this Association who has felt the effects firsthand; some in the moment, some in the immediate aftermath, some in the cleanup.

In a letter dated 02 December 1985 from the Board of Registration for Professional Engineers and Land Surveyors (BORPELS) to all County Surveyors and City Engineers:

"Land is one of California's most precious assets, the ownership of land, and consequently the ability to define boundaries is dependent on monuments and their perpetuation."

Natural disasters have the potential to destroy every improvement on a property, however, property monumentation has the potential to survive many natural disasters. The danger for the monumentation lies in the cleanup phase.

While I was serving as the Monument Preservation Committee Chairman, one member of our Association, Mr. Mike Quarteroli put together a Pre & Post Disaster Survey Monument Preservation Guide specifically for Wildfire Events. He studied a number of fires, particularly the cleanup after effects and realized the danger to monument preservation. He reported his findings and laid out a plan of action for monument protection and preservation in that Guide. He prepared an outstanding piece of work.

In 2020, copies were sent to each of the County Surveyors. The intent of the Guide was not to admonish the County Surveyors and their respective Counties into submission, but rather an outstretched hand of help in a time of need. How can CLSA help your County prepare for the inevitable, and how can we help afterwards.

The Introduction of that 2020 Guide reads, in part:

"The loss of life, homes, personal property, and basic infrastructure in California as a result of wildfires is overwhelming. However, due to the resilience of Californians, the cleanup and rebuilding process often begins immediately after a catastrophic event. A major part of the success of this process relies on the preservation of the survey monuments marking the location of property, utilities, roadways, and additional infrastructure."

"The California Land Surveyors Association (CLSA) is reaching out to each County Surveyor in an effort to assist them in their Emergency Operations. We offer our assistance particularly as you address the needs of Monument Preservation as defined in Section 8771 of the Professional Land Surveyors Act during your rebuilding and restoration efforts. As County Surveyors, you are at the forefront of this effort."

Also on that forefront is you. As a Professional Land Surveyor, you are the expert. Reach out to your local City and County officials. Offer to share CLSA's Monument Preservation presentation with their organization and train them. Offer to share the Pre & Post Disaster Survey Monument Preservation Guide. If you would like copies of said Presentation (as an

editable Powerpoint file) or the Guide, contact Mikey Mueller, the Association Monument preservation Committee Chair.

Even if you're unable to share them with your local officials, I'd like to encourage each of you to obtain a copy of each for yourselves.

As I close my last President's Letter, I'd like to revisit a topic which I wrote about in my first eNews message in February of 2024: Chapter Mentorship.

While I toured the State visiting with the Chapters, one of the topics that garnered much discussion and easily the most positive response was that of Chapter Mentorship by the Executive Committee. As I shared my experience with the struggles I had as a Chapter President and as a new Director, I found that nearly all other Officers in every Chapter had (or has) the same struggles. Those common struggles include membership outreach and retention, Chapter reports, Chapter meetings and speakers, Director's duties, and an often misunderstood relationship between the Chapters and the Board. Daunting tasks for many of us, and incredibly difficult to figure out on your own.

It shouldn't be that way.

None of us obtained licensure on our own. We became the Surveyors we are with the help of the mentors we had, whether they were employers, other crew members or coworkers, or any of the other multitude of professional relationships we may have. As I have progressed through the Executive Committee Chairs, I have received and welcomed great counsel and mentorship from many past Ex. Com. members, past and present Committee Chairs, and Kim at the Central Office. ALL of Past Presidents who have reached out to me want the Executive Committee to be the best it can be. They don't want it for me; they want it for the Association. I want to pass that forward. That's where Chapter Mentorship by the Executive Committee comes in.

In 2021, when I was first installed on the Executive Committee as the Treasurer, I brought up the idea of the Ex. Com. members working with the individual Chapters. (In the interest of full disclosure, this idea was floated to the Association by Past President Jay Seymour around 2015.) 2021 President Rob McMillan divided up the Chapters into five groups and assigned an Ex. Com. member. Those groups remain virtually unchanged; the only significant change being that of the Ex. Com. mentor. By design, the Ex. Com. members will mentor the same four Chapters throughout their tenure on the Executive Committee. When the Past President is retired, the newly installed Treasurer will take on the duties as mentor for those Chapters.

The Executive Committee Members work at the behest of the Board, and ultimately, the Association membership. The Executive Committee is there for you. Do not hesitate to reach out to them.

## WHERE IN CALIFORNIA IS THIS?


## Where IN CA is This?



The December Where IN CA? was provided by Dave Moritz, PLS, as he traveled to the famous – OK, slightly famous – Pioneer Town. The photo was taken looking up the steep grade on eastbound Highway 62 approaching Yucca Valley, CA, late in the afternoon of December 14<sup>th</sup>, 2024. For those who know, SBD 062 PM 7.00.

The one person who correctly identified the location was Andrew LaBine, PLS, President of Praxis Land Surveying of Fresno. Andrew recognized the location as, "looking east on CA 62 at the Yucca Park Rd intersection. Lat: 34° 6'11.49"N, Long: 116°29'35.76"W. My grandparents live in Yucca Valley, so I have made that drive many, many times, so the picture looked really familiar. I knew it was at an intersection due to the highway signs, so I looked on Google Street View at the first intersection west of the summit right before you (crest the grade and) drop into Yucca Valley, and the road signs matched. # SURVEY MONUMENT PRESERVATION PRIOR TO WILDFIRE PREVENTION & RESTORATION PROJECTS

Enjoy this timely article by CLSA's own Mike Quartaroli, LS, originally written in September 2024.

One aspect of wildfire prevention and restoration projects is that they consistently overlook the preservation of survey monuments. While the fires themselves may contribute somewhat to the destruction of survey monuments, it is typically the uncontrolled cleanup and restoration efforts that destroy survey monuments. Wildfires introduce many categories of prevention and restoration projects as seen below:

- Roadway Wildfire Debris Removal
- Roadway Utilities Restoration
- Roadway Utility Undergrounding
- Roadway Fuel Reduction
- Roadway Hazard Tree Removal
- Private Lands Fuel Reduction
- Private Lands Fuel Break
- Private Lands Hazard Tree Removal

- Private Lands Debris Removal
- Public Lands Fuel Reduction
- Public Lands Fuel Break
- Public Lands Hazard Tree Removal
- Public Lands Debris Removal
- Rangeland Fence Restoration
- Fire Salvage Timber Logging

All of these categories put survey monuments in jeopardy of being disturbed or destroyed.

More and more, County Resource Districts from wildfire vulnerable communities are forming partnerships with other County, State, and Federal agencies to propose and execute wildfire prevention and restoration projects. The size of these prevention and restoration projects may overshadow all other capital improvement projects these communities may have. There are currently no standardized guidelines in forming these partnerships and who to include in the partnership and who to notify of the proposed projects. The scale and popularity of these projects is a new phenomenon and project sponsors are slowly learning that these projects are affecting many unforeseen County departments. Two significant and important unforeseen County departments not

typically included in the partnerships or notified by the partnerships, are County Surveyors and County Engineers. County Surveyors and County Engineers must remain alert for announcements of these projects. Consequently, County Surveyors and County Engineers must assert their needed involvement, as advisors, if not previously included or notified by the partnerships. Eventually, partnership standards and protocols must be developed and adopted that would automatically include County Surveyors and County Engineers....
